- Official College Transcripts (if applicable)

APPLICATION DEADLINES

- Fall Enrollment—Harcum College operates on a rolling admissions basis. However, priority deadline for applications is May 1st
- Spring Enrollment—Harcum College operates on a rolling admissions basis.

FINANCIAL AID DEADLINE

- FAFSA form priority deadline is April 1st
- PHEAA Grant deadline is May 1st



HARCUM COLLEGE

HARCUM COLLEGE operates under a rolling admissions policy, which means that the Admissions Committee reviews each application file as soon as it is complete. Applicants will be notified within 10 working days of a decision, and of any conditions necessary for entry. Prospective students are advised to apply as early as possible to ensure admission to the program of choice.

Applications are processed without discrimination on the basis of race, color, religion, sex, age, national origin, handicap or disability, veteran status, or marital or parental status.
